Rules and Regulations



Rules

"The Great Gumbo Cook-off" 37th Annual Medina Lake Cajun Festival Saturday, September 23 2017 11:00 AM to 10:00 PM

Entry fee: \$40 to be enclosed with an entry form. One gumbo entry per booth.

Awards: The Gumbo cook-off awards will be divided into 3 categories: an Amateur Division, Culinary Division (schools), and a Professional Division (includes restaurants, caterers, those who cook for a living or sell to the public, etc.) Trophies will be awarded in all three divisions, depending on entry numbers. There will also be a showmanship trophy awarded to the booth that shows the most creativity, flair and fun in the presentation of its booth. We strongly recommend that you participate in this.

Sales: Gumbo is to be sold to the public from **11:00 AM to 10:00 PM** or until sold out. Seafood gumbo will sell for \$3.00 for a 7 oz. cup, and non-seafood gumbo for \$2.50 per 7 oz. cup. Contestants will provide their own rice. The MLBA will provide you with all cups, spoons, food service gloves, and napkins for your gumbo, and a sign with the price of your gumbo.

The minimum amount to bring is 5 gallons. Most contestants sell out of their gumbo to our large crowd before the festival closes, as gumbo is the "hub" of our festival and is much in demand by our visitors. The more gumbo you bring, the more sales you can expect. Gumbo must be made on festival grounds. The use of commercially prepared roux in jars is permitted, and contestants may want to consider the use of minute rice to serve in gumbo. These rules are required to meet state health requirements. All gumbo must be sold to the public and may not be given away or sampled. Gumbo sales are done on a ticket basis only. Contestants will not have to worry about handling cash. A ticket container will be provided to you and please be careful with it. Contestants may close their booths before 9:00 PM, but tearing down and vehicle entry are not allowed until after 10:00 PM. Contestants may donate all of their proceeds to the Medina Lake Betterment Association, Inc. or keep up to 70 % to cover your expenses. At least 30 % of your gumbo sales are required to be donated to the MLBA. When your gumbo sales are complete and after the awards ceremony, cook-off chairpersons will take your tickets to the finance office to obtain a check for your portion of gumbo sales. Contestants will count their own tickets and bundle them in groups of 50. Tickets submitted by 07:00 PM will be paid out the same evening by check. Tickets processed after 07:00 will be paid by mail within 1 week.

Contestants are to prepare and cook in as sanitary manner as possible. Cooking conditions are subject to inspection by Gumbo Cook-off chairpersons and the state health department. Food service gloves should be worn as you sell your gumbo. Unsanitary conditions may be cause for team disqualification. Food must be kept at a safe temperature (140 degrees or more for hot food and 39 degrees or less for cold food) while serving, and ice will be available for purchase for \$4.00 per 20# bag.

MLBA: The Medina Lake Betterment Association, Inc. is a non-profit, civic organization that hosts the Medina Lake Cajun Festival as its primary fund-raiser. All proceeds support the upkeep of the facilities and the community programs of the MLBA, Inc..

The greatest Cajun Bands from the great state of Louisiana will be at the festival.

Rules and Regulations (cont)

Booth Site Area: The gumbo cook-off area is located in the back of the property beneath many large trees. Last years participants will be given first option to retain existing space if notified by 09-01-17. After this date, all booth spaces will be assigned by the committee.

Booth size is 15' x 15'. Contestants may use any kind of Cajun, Mardi Gras or Louisiana themed booth design, and are encouraged to decorate extensively and to have "fun" with the booth and the public. No vehicles or trailers (except cooking trailers) may be used to build your booth. Contestants must bring their own equipment including tables, chairs, canopies, butane cookers, fire extinguishers, etc. Electricity will not be available for contestants. You must clean up your booth site by the festival end, and return site to its original condition. Dumpsters will be provided but please bring your own trash bags. The floor of your booth must be covered with tarp, mats, or other protective flooring. Music is allowed in your booths, but must be turned off while our bands are playing. Trinkets or promotional items may be handed out to festival goers, but again, no food is to be given away. Booth set up will be Friday noon till 7:00 PM and Saturday 8:00 to 10:00 AM. There is no security Friday night, so we suggest supplies and cooking equipment be brought Saturday morning.

Complimentary Admissions: Each team will be given 4 free wrist bands which the team leader will pick up Saturday morning at the Gumbo Committee Booth. Wrist bands must be worn by staff at all times. Additional wrist bands may be purchased at the gates for \$10.

Judging: The judging will be blind judging done by experts using numbered entries. Your sample for judging will be collected by committee members between 12:30 & 3:00 PM, and a numbered cup will be brought to you prior to turn in time. You will be given an approximate turn in-time for your entry. Please turn in a 1/2 cup sample with no rice. Cups must be free of damage and no markings. The judges will base their decisions on taste, ingredients, roux (or other base), aroma and appearance. There will be no preference given by the judges to seafood or other types of gumbo. All will be judged equally. All cook-off teams must be present at the Fais Do Do Pavilion stage by 5:30 PM for the awards ceremony. Please arrange for one of your team members to stay in your booth to continue gumbo sales.

Check-in: Festival grounds open at 8:00 AM Saturday morning for gumbo cook-off contestants, arts and craft vendors and delivery trucks. All vehicles must be off the grounds by 10:00 AM. None are allowed to remain on festival grounds. Gumbo cook-off committee members will be present to help contestants get to their booth locations or give other help as needed. Please unload your supplies and equipment and move your vehicle to the parking area as quickly as possible. Actual check-in begins at the Gumbo Cook-off Head quarters at 9:00 AM. This booth is located in the cook-off area and is where you will be issued your paper goods, ticket cans, and rubber bands. Additional paper goods are available at this booth throughout the day.

SUMMARY OF RULES AND REGULATIONS

<u>General:</u> The Medina Lake Cajun Festival & Great Gumbo Cook-off will be held rain or shine. Contestants will be allowed to bring their own water and sodas. <u>Alcoholic beverages are strictly prohibited and are a violation of festival rules. We must comply with all State Liquor Laws. Non-compliance may jeopardize the <u>MLBA's Liquor license and can disqualify you.</u> Beer, wine coolers, and wine margaritas, are for sale on our grounds. TABC agents and county law enforcement agents will be on the grounds so it is essential for both you and the MLBA to comply. Contestants must follow Texas Health Dept. and MLBA rules and regulations.</u>

No food other than gumbo may be prepared, cooked or handed out from your booth. Please keep your booth clean and hands washed as you are selling food product to our public.

No glass containers are allowed on the festival grounds.

No animals, except service animals for handicapped persons, are allowed on festival grounds.
